## Security controls

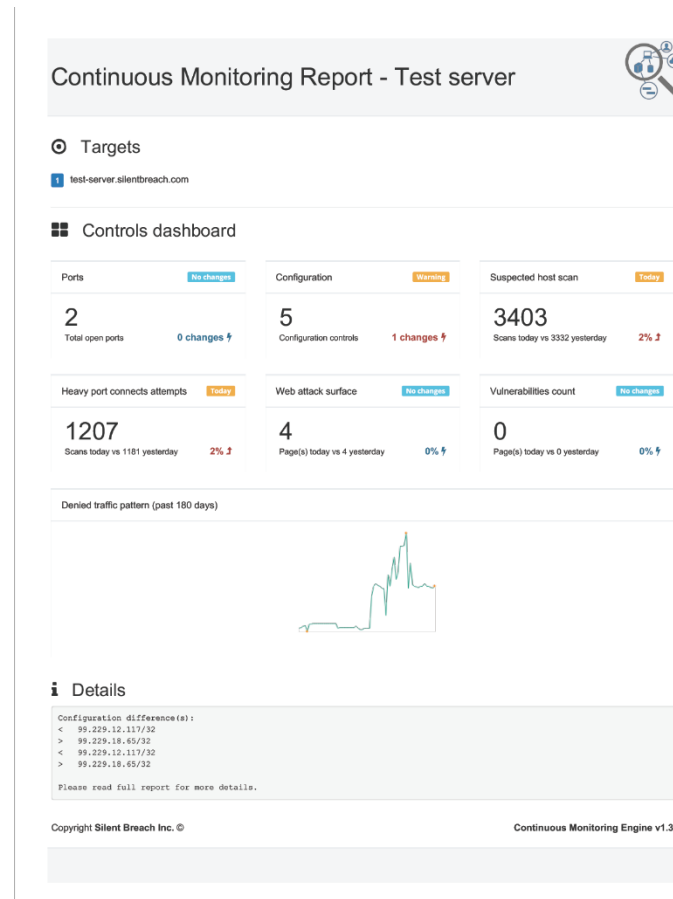
Security controls defines what should be monitored by Continuous Shield Protect™ in order to offer the most coverage for your organization. We use state-of-the-art security control models to protect your organization.

## Daily reports

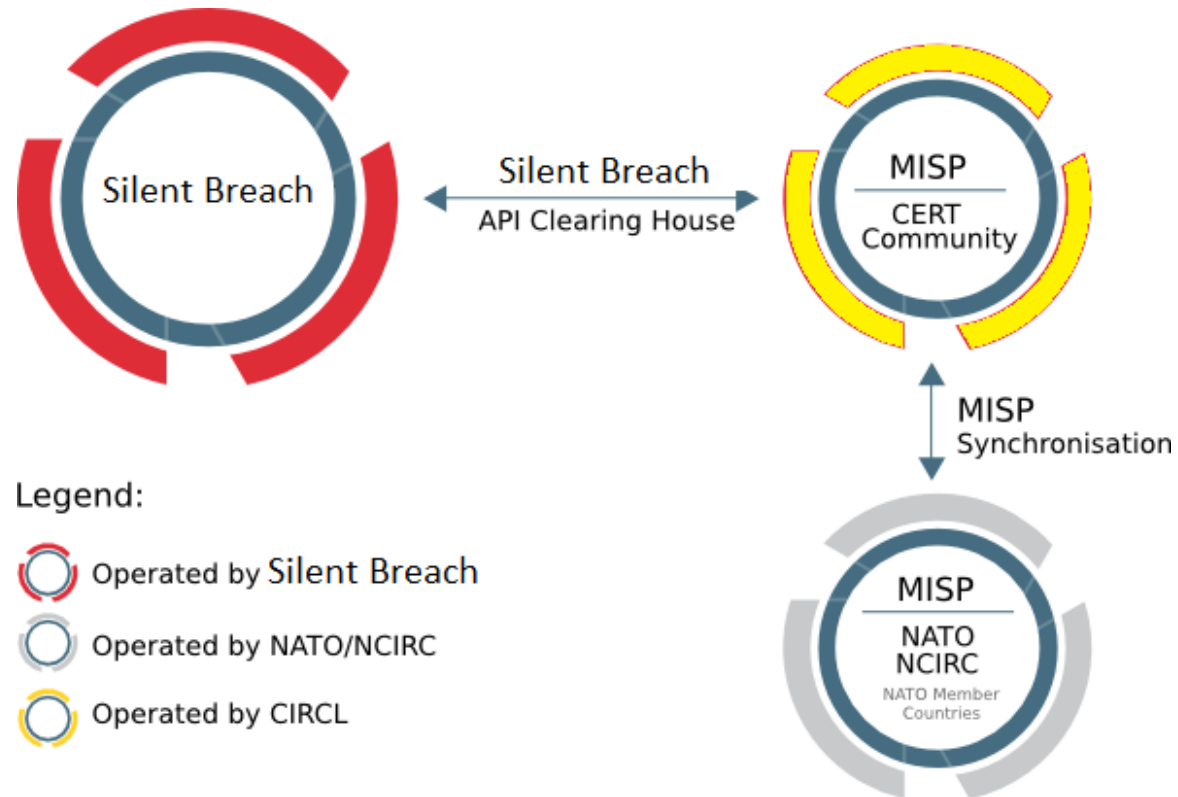
Our proprietary technology offers daily updates on your security posture by combining home grown vulnerability scanners results and historical comparison of your network configuration (Firewall, routers, IDS/IPS, etc..), open ports (TCP/UDP), attack surface measurement and thorough analysis of your log files.

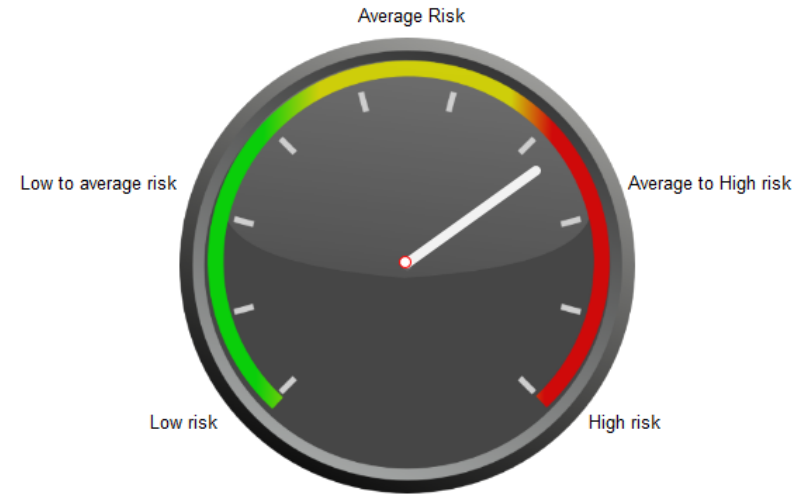
# Network Penetration testing

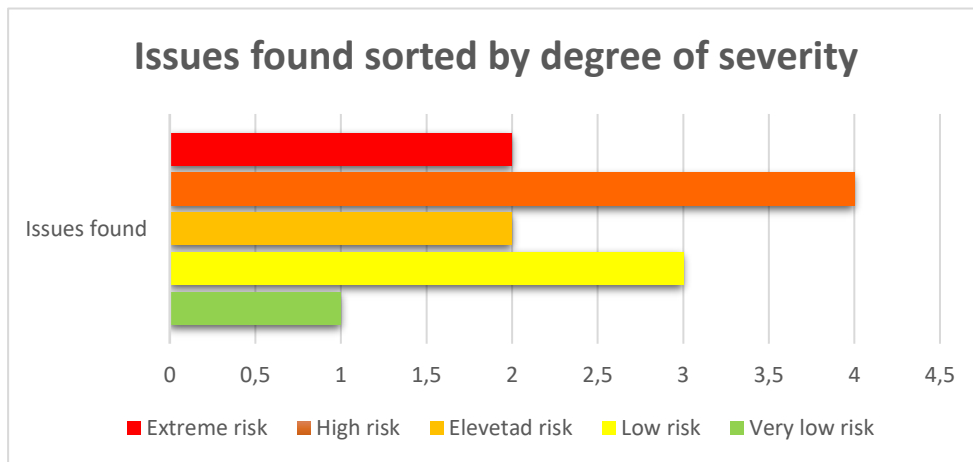
## Clear and straightforward reports.

## Rootkit and backdoor detection

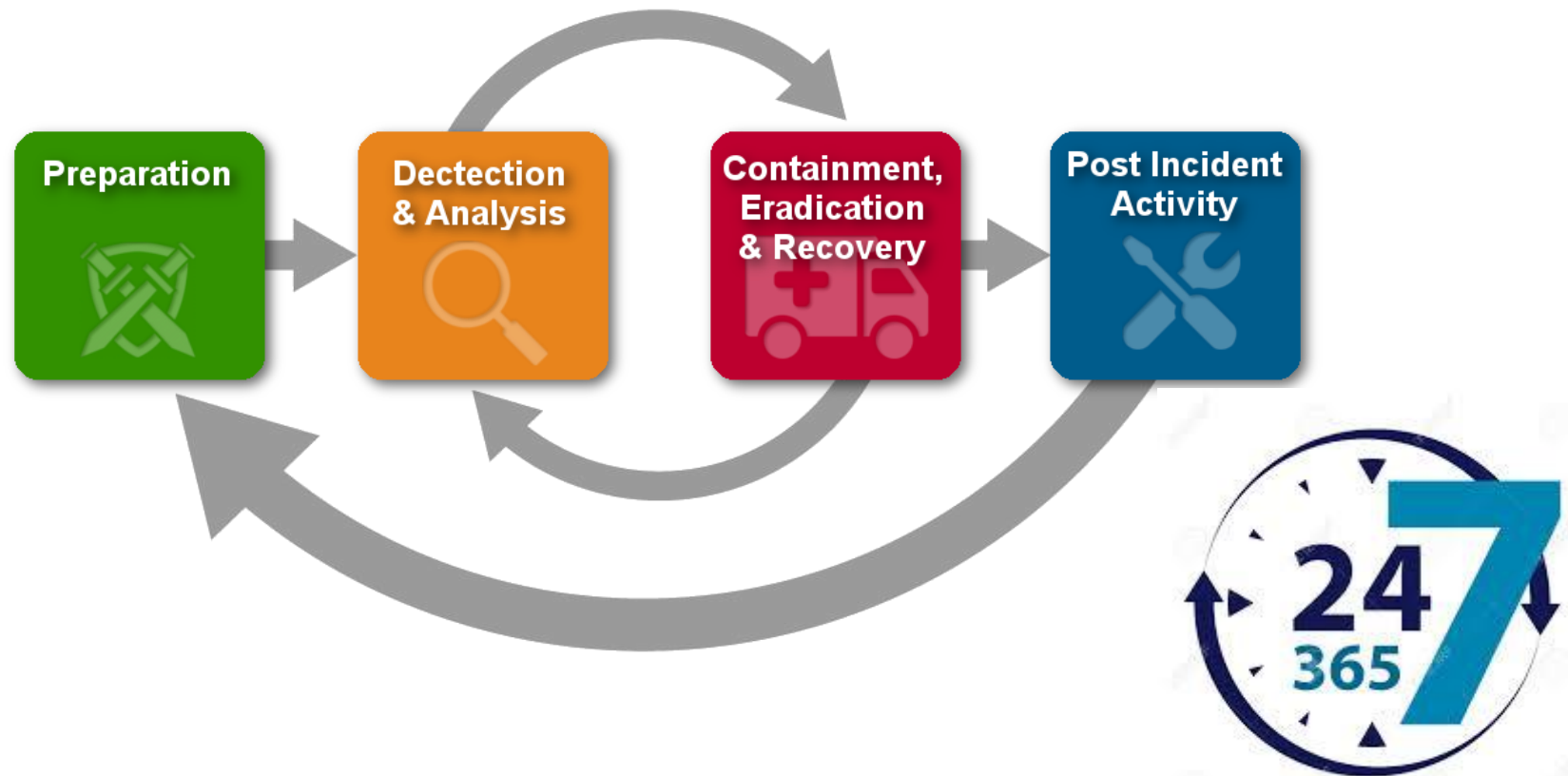
